

EGİS TÜNEL İŞLETMECİLİĞİ ANONİM ŞİRKETİ COOKIES CLARIFICATION TEXT

1. Data Controller

Pursuant to the Personal Data Protection Law numbered 6698 ("PDPL"), with this Cookies Clarification Text (the "Clarification Text") we, Egis Tünel İşletmeciliği Anonim Şirketi ("ETİ" and/or the "Company"), as the Data Controller, would like to provide our valued visitors and users with information with respect to the cookies used on www.egistunelisletmeciligi.com of the Company (the "Site") as per our clarification obligation under the PDPL.

We, as the Company, use small files, which are stored on your devices such as computer, mobile phone, and tablets, which you access while visiting the Site, for the limited purposes to provide you a better service while using and visiting the Site, to improve and enhance your experience, to personalize the advertisements, which you view while using the internet, based on your preferences (the "Cookies").

2. Method of Collection of Cookies and Legal Basis of Processing

The Company processes the Cookies electronically for the purposes and within the scope, which are indicated in Section 3 below, within the context of our visitors' visit to the Site and based on the legitimate interest of the Company. The personal data, which are collected through the Site, are processed pursuant to the personal data processing terms set forth in the Article 5 of PDPL and this Clarification Text.

3. Cookies That Are Used on the Site and Purposes of Use

The primary purposes of the Company for using Cookies are indicated below:


- Carrying out principal functions, which are necessary for the Site to actively operate
- Increasing the performance of the Site by analyzing the Site,
- Providing ease of use to the users by increasing the functionality of the Site

We, the Company, use both first party cookies (which are stored on directly by the Site that you visit) and third party cookies (which are stored on by the servers, other than the Site, which you visit on behalf of the Company) for achieving the purposes indicated above for our visitors. These Cookies are the cookies, which are required to be used in order for the Site to function efficiently, the functionality cookies and the analytics/performance cookies.

Mandatory Cookies: These cookies are the cookies, which are absolutely required for the Site to operate properly. These cookies are needed in order to manage the system, to prevent fake transactions and if they are blocked the Site will not operate.

Functionality Cookies: These cookies are the cookies, which are used to ensure our visitors experience a more advanced and easier experience. For instance, it fulfills the functions of remembering your preferences, ensuring that you easily access the content of the videos and social media on the Site.

Analytics/Performance Cookies: These cookies are the cookies, which ensure that we can analyze and interpret the operation of our visitors and improve the Site by interacting with our visitors.

4. To Whom And For What Purposes the Cookies May Be Transferred

The Company may transfer the personal data under this Cookies Clarification Text to the thirds persons, from which the Company receives services, the business partners, the suppliers and legally authorized public institutions and organizations for achieving the limited purposes indicated above and in accordance with the legislation.

5. Changing Cookie Preferences


Managing cookie preferences is under your control as our users. Internet browsers automatically accept the Cookies and for detailed information on cookie management you can use the cookie settings or the help options of your browser.

Although, as our visitors, your preferences are essential, we would like to remind you that if certain Cookies, which are mandatory for the operation of the Site, are blocke, certain services and/or functions of the Site may not operate partially or entirely.

6. Your Rights

To the extent that your personal data is processed by the Company and that the Company processes your personal data as the data controller, your are entitled to the rights, which are indicated below, pursuant to article 11 of the PDPL:

- a. To learn whether any of your personal data is processed or not,
- b. To request information in relation to the activities of processing of your personal data,
- c. To learn the purposes of the processing of your personal data and whether these personal data are used in compliance with these purposes,
- d. To be informed on the third parties, in case the personal data are transferred to third parties within the country or abroad,
- e. In case the personal data are processed incompletely or inaccurately, to request the rectification of such incomplete or inaccurate data and to request that the action taken in this regard be notified to the third parties, to which personal data are transferred,



- f. In case, even though the personal data are processed in compliance with the PDPL and other relevant provisions of law, the bases for processing ceases to exist, to request the deletion, destruction or anonymization of the personal data within 30 (thirty) days pursuant to the provisions of the Regulation on Deletion, Destruction or Anonymization of Personal Data and to request that the action taken in this regard be notified to the third parties to which personal data is transferred,
- g. To object to the unfavorable results, which may occur as a result of processing of the personal data by automated means, and
- h. In case you suffer any damages due to unlawful processing of your personal data, to request the compensation of the damage.
